### IT IS HEREBY AGREED AS FOLLOWS:

#### AMENDMENT NO. 1

It is hereby agreed to amend Contract No. 4100118265, effective December 13, 2019, as follows:

#### I. CONTRACTOR SERVICE RESPONSIBILITIES

Paragraph L is amended to read as follows:

- L. Contractor shall conduct the project at the San Timoteo Landfill and additional locations to be approved by both the County and DonkeyLand. The first being the San Timoteo Landfill between the hours of 8:00 am and 4:30 pm starting on November 1, 2019. The second location will be private property located in the San Timoteo Canyon area near or on Pilgrim Road. The second project location will take place starting on November 16, 2019. Third and additional locations will be identified by DonkeyLand and approved by the County. The project at all selected locations should be completed by April 30, 2020. Prior to commencing the project at the additional locations, Contractor shall obtain from the owners of the property written authorization to enter upon the property and conduct the project. The written documentation must be provided to the County prior to commencement of the project on the private property. The Contractor shall assume all responsibility and liability for the program at each location.

**VIII. TERM**

Section VIII is amended to read as follows:

This Contract is effective as of November 1, 2019 and is extended from its original expiration of December 31, 2019, to expire on April 30, 2020, but may be terminated earlier in accordance with provisions of Section IX of the Contract.

All other terms and conditions of Contract No. 4100118265 remain in full force and effect.
