After safe and successful capture of 256 burros, Peaceful Valley Donkey Rescue (PVDR) and the Department of Public Health, Animal Care Division (County) have mutually agreed to termination of their contract for the provision of wild burro rescue and relocation services. This letter serves as mutual agreement of termination of the contract effective immediately upon execution of the below acknowledgment by both parties. Mutual agreement of contract termination is acknowledged upon signature of this letter by each party below.

Should the County determine a path to move forward for partnership with PVDR for provision of these wild burro rescue and relocation services in the future, a new contract will be drafted in collaboration with PVDR at that time.


